ON ABOVE DATE AND TIME THE FOLLOWING VICTIM OFFICERS RESPONDED TO A DOMESTIC DISPUTE INVOLVING THE DEFENDANT AND HIS PREGNANT GIRLFRIEND AT THERE APARTMENT AT ABOVE LOCATION, MIAMI POLICE CASE NUMBER 2104010020299. 
